Dear Members of Congress,

On behalf of the undersigned organizations, we respectfully request your support for the inclusion of Puerto Rico in the Supplemental Nutrition Assistance Program (SNAP). We advocate for the inclusion and enactment of language in the 2025 Farm Bill and/or the passage of H.R. 5168, the Puerto Rico Nutrition Assistance Fairness Act, that would facilitate a structured transition for Puerto Rico into SNAP. Puerto Rico's current status quo is detrimental to American working families, and America's farming communities. These measures aim to address nutritional disparities experienced by American families and children residing in Puerto Rico, ensuring that, during periods of economic decline, public health emergencies, natural disasters, and increasing food insecurity, U.S. citizens in Puerto Rico have equitable access to nutrition assistance—comparable to that available to the most vulnerable populations across the continental United States. The central issue is not whether Puerto Rico should participate in SNAP, but rather why it has remained excluded from this established program for such an extended period.

Since 1982, U.S. citizens in Puerto Rico have been excluded from SNAP and instead receive limited nutrition assistance through a capped block grant under the Nutrition Assistance Program (NAP). This grant, funded at only 75% of what the Food Stamp Program would provide, led to stricter eligibility and reduced benefits, worsening food insecurity for Puerto Rico's residents. The proposed legislative provisions outline a measured and pragmatic approach for transitioning Puerto Rico to SNAP, with the intent to minimize disruptions and promote effective implementation over a 10–15-year period.

Years 1–10: Puerto Rico and the USDA will focus on developing the necessary infrastructure for SNAP, including integration into data reporting systems, the migration of retailer networks, and comprehensive workforce training for SNAP operations.

Years 11–15: The transition will involve aligning benefit levels and administrative processes with SNAP standards to ensure a seamless experience for participants and businesses.

This phased strategy allows both Puerto Rico and the USDA to prepare thoroughly for full participation in SNAP while enabling policymakers to address Pay as You Go (PAYGO) requirements and budget responsibly.



Puerto Rico has implemented an Electronic Benefits Transfer (EBT) system, updated its technology, phased out cash benefits, and trained employees to support program administration. Recent reports from United States Department of Agriculture (USDA) and the Food and Nutrition Service (FNS) have evaluated Puerto Rico's compliance with relevant regulations, planning requirements, and monitoring standards positively. Including Puerto Rico in SNAP is projected to affect food security and provide mechanisms for accountability, workforce development, and disaster assistance distribution.

Puerto Rico imports approximately 85% of its food and goods from the mainland United States. By transitioning to SNAP, estimates suggest Puerto Rican households would have increased purchasing power, resulting in greater demand for products such as pork, poultry, beef, soybeans, corn for livestock feed, dairy products (including cheese and milk), as well as rice, canned foods, cereals, and processed goods. This change would create additional markets for U.S. farmers, food processors, and manufacturers. Estimates indicate that every \$1 in SNAP benefits distributed generates approximately \$1.50–\$1.80 in economic activity. Transitioning Puerto Rico to SNAP is projected to return significant financial activity to the U.S. economy, potentially benefiting sectors such as agriculture, transportation, retail, and manufacturing. In turn, including provisions to transition Puerto Rico into SNAP within the 2025/2026 Farm Bill or passing H.R. 5168 would address federal policy differences, extend support during periods of acute need, and enhance agricultural economies both on the island and in the fifty states, enhancing prosperity nationwide.

Nearly 6,00,000 members of the Puerto Rican diaspora currently live throughout the United States. Analysis of the 2022 American Communities Survey suggests that the Puerto Rican diaspora in the United States enjoyed a purchasing power of \$170 billion, fueling the nation's economy, and representing an of the most influential voting blocs across the country. Many maintain connections with the island and their culture, despite living at a distance. Relationships with relatives and friends on the island are often sustained through regular visits and financial support, which contributes to Puerto Rico's economy.

Your co-sponsorship of H.R. 5168 and/or Farm Bill language enabling a transition from NAP to SNAP would significantly support the interests of Puerto Ricans in the U.S. mainland, by allowing Puerto Rico and its citizens to fairly join the rest of the country in participating in SNAP.
